Working together, patients and scientists hope to improve the quality of life for patients with eosinophilic GI diseases (EGIDs) like eosinophilic esophagitis (EoE), gastritis (EG), gastroenteritis (EGE), and colitis (EC).

This survey is intended for patients with EGIDs who are adults (18 years or older), parents or caregivers of children with EGIDs (younger than 18 years), or people without EGIDs who would like to help by participating as healthy controls.
